Indiana Manufactured Home Installer Licensing Course

This course is designed specifically for Installers and Foundation Builders for manufactured housing in Indiana to comply with the educational mandate established by the **Indiana Manufactured Home Installer Licensing Board** through 879 IAC 1-1. Individuals completing this entire course will receive an individualized **certificate of completion** at the end of the SECOND HALF on day 2 of this course. This certificate of completion is an evidential part of the licensure application process and will satisfy Section 879 IAC 1-4-2 for education to become a licensed manufactured home installer within the State of Indiana.

Who is Required by Indiana Law to Attend:

Manufactured Home Foundation Contractors*

Installers* of manufactured homes within the State of Indiana.

Retailers* who wish to become licensed to install the manufactured homes they sell.

MH Community Operators* who offer installation services to residents.

*Note: A minimum of one person is required to hold an installer license for each manufactured home installed.
