

## **IMHA/RVIC Members . . . It's Board Nomination Time!**

Every year we ask our membership to nominate candidates who will serve as members of our Board of Governors. This is your opportunity to help make something happen. We encourage you to consider self-nomination or consult with your peers and nominate them. Our mission "to protect and promote our membership" can only be accomplished with your help. The Association staff has prepared this guide to provide information on the nomination procedures. Please read it carefully. ***WHO CAN SERVE ON THE BOARD?*** Association members in good standing (paid up member for 12 consecutive months prior to nomination) can only be considered.

### ***WHICH CATEGORIES NEED TO BE FILLED?***

#### **MH Council**

1 Retailer  
1 Community  
1 Service Firm

#### **RV Council**

1 RV Retailer  
1 Supplier  
1 Campground  
1 Southern Region Rep

***WHO CAN I NOMINATE?*** You may nominate for any or all of the above divisions. The nominee must be a member in good standing from that division. Region Representatives may be nominated from any division within the region.

***WHAT HAPPENS AFTER I NOMINATE?*** The staff will contact all nominees. If they qualify and accept, they will be placed on the official ballot for elections.

***WHEN DO I NEED TO NOMINATE?*** Written nominations must be received at Association Headquarters no later than 5 pm on Friday, August 15, 2008. You may mail, fax, or hand deliver nominations -- *no phone nominations will be accepted*.

***WHAT IS EXPECTED OF BOARD MEMBERS?*** Board members meet four-five times a year, usually in Indianapolis. They are asked to:

- *foster the best business practices in all branches of the MH and RV industries*
- *encourage high professional and ethical standards in the customs and commercial aspects of the MH and RV industries*
- *acquire, preserve, and disseminate trade information pertaining to new developments in the area of the MH and RV industries*
- *combat unduly restrictive regulations and promote the welfare of the MH and RV industries*

***HOW LONG DO BOARD MEMBERS SERVE?*** A term of office is for three (3) years.

- Terms will begin on January 1, 2009

***WHAT IS THE ELECTION PROCEDURE?*** After nominations are confirmed, ballots will be mailed to all members of each division or region.
